## **Organizer**

1. The Jean Coutu Group (PJC) Inc. is the Organizer ("the Organizer") of the "PJC Advent Calendar Contest - 2023 Edition" (the "Contest")

#### **Contest Date**

2. The Contest will run from December 1, 2023 at 12 a.m. (Eastern time) ("Contest Start Date") and up until January 4, 2024 at 10:59 p.m. (Eastern time) ("Contest Close Date").

## **Eligibility**

- **3.** The Contest is intended solely for Quebec, Ontario and New Brunswick residents who have reached the age of 16 by the Contest Opening Date.
  - \*If the Entrant is a minor, as defined by the jurisdiction of the Entrant's province of residence, the signature of a parent or guardian is required to claim the prize, otherwise the minor's selected entry will be disqualified.
- 4. The Organizer's employees of all establishments affiliated or related to the Organizer (all employees of The Jean Coutu Group and all employees of the Jean Coutu and Brunet network), their representatives and official advertising or promotional agencies for the Contest (the "Partners") or any other party directly related to the holding of this Contest, as well as the persons with whom they are domiciled, whether or not they are related, are not eligible To enter this Contest.

#### **Facebook Entry**

- 5. To enter the Facebook Contest, an Entrant must have an Internet access and a Facebook account. To enter the Contest, each contestant must must be a registered Facebook user.   - Limit of one entry, per Facebook account, per person for the duration of the Contest.
- **6.** The Entrant can only use one (1) Facebook account in this Contest. Multiple Entrants are not allowed to share the same Facebook account.
