# CONTEST INSTAGRAM "24 days of Holiday magic"

## Contest Date

2. The Contest will run from December 1, 2020 at 10 a.m. (Eastern time) ("*Contest Start Date"*) and up until January 4, 2021 at 10:59 p.m. (Eastern time) ("*Contest Close Date"*).

## **Eligibility**

**3.** The Contest is intended solely for Québec, Ontario and New-Brunswick residents who have reached the age of 16 by the Contest Opening Date.

\*If the Entrant is a minor, as defined by the jurisdiction of the Entrant's province of residence, the signature of a parent or guardian is required to claim the prize, otherwise the minor's selected entry will be disqualified.

4. #### Instagram Entry
