

# CONTEST Rules

# "Your beauty moment gift"

1. The Jean Coutu Group (PJC) Inc. (the "Organizer") is the Organizer of the "Your beauty moment gift" (the "Contest"). For the purposes of these rules, L'Oréal Canada is hereinafter defined as the "Partner." The Partner acts solely as a prize supplier and cannot be held responsible for anything related to the conduct of the contest and has no role in the management of this contest. #### **Eligibility and Registration**

- 2. The Contest begins on November 18, 2021 at 12:01 a.m. (*Eastern Time*) (the "*Contest Opening Date*") and ends on November 24, 2021 at 11:59 p.m. (*Eastern Time*) ("*Contest Closing Date*").
- 3. The Contest is intended solely for Quebec residents who have reached the age of 16 by the Contest Opening Date.
- 4. The Organizer's employees of all establishments affiliated or related to the Organizer (all employees of The Jean Coutu Group and McMahon head office and all employees of the Jean Coutu and Brunet network), their representatives and official advertising or promotional agencies for the Contest (the "Partners") or any other party directly related to the holding of this Contest, as well as the persons with whom they are domiciled, whether or not they are related, are not eligible to enter this Contest.

### **Participation**

5. To participate in the contest, the participant must go to the Cosmetics counter of a participating Jean Coutu store and ask for a scratch card (while supplies last). No purchase necessary to receive a scratch card. To be valid, the scratch card must be scratched in the presence of the employee who gave the scratch card to the participant.
