

Rules FACEBOOK Holiday Magic

<u>Organizer</u>

1. The Jean Coutu Group (PJC) inc. is the Organizer of the "Holiday Magic" contest (the "Contest").

Contest Date

2. The Contest will run from December 1, 2021 at 10 a.m. (Eastern time) ("Contest Start Date") and up until January 4, 2022 at 10:59 p.m. (do to take care of themselves on a daily basis."Eastern time) ("Contest Close Date").

Eligibility

3. The Contest is intended solely for Quebec, Ontario and New-Brunswick residents who have reached the age of 16 by the Contest Opening Date.

*If the entrant is a minor, as defined by the jurisdiction of the entrant's province of residence, the signature of a parent or guardian is required to claim the prize, otherwise the minor's selected entry will be disqualified.

4. Facebook Entry
